#### APPROVING RESOLUTION NO. 2021-052 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 1<sup>ST</sup> SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM-CY 2021 OF THE MUNICIPALITY OF SISON, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2021-052 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sison, Pangasinan has formulated the municipality's 1<sup>st</sup> Supplemental Investment Program for CY 2021 and endorsed through MDC Resolution No. 01-2021 dated February 19, 2021 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

**WHEREAS**, the 1<sup>st</sup> Supplemental Investment Program of Sison, Pangasinan with a total investment requirement amounting to P228,290,664.26 covers the implementation of various development programs/projects not included in their approved CY 2021 Annual Investment Program;

WHEREAS, the funding support for the implementation of the programs/projects embodied in their 1<sup>st</sup> Supplemental Investment Program are the following: Supplemental Budget No. 1 enacted on March 1, 2021 through Appropriation Ordinance No. 1, Series of 2021, amounting to P38,490,664.26; Local Government Support Fund-Disaster Response and Reconstruction Assistance Program (LGSF-DRRAP) – P100,000.00; Local Government Support Fund-Financial Assistance to LGUs (LGSF-FA to LGUs) – P189,700,000.00;
