APPROVING RESOLUTION NO. 19-016 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2 FOR CALENDAR YEAR 2019 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 19-016 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council of San Carlos, Pangasinan has prepared the city's Supplemental Investment Program No. 2 for CY 2019. This was endorsed thru CDC Resolution No. 02-19 dated March 7, 2019 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 19-016 dated March 18, 2019;

WHEREAS, the Supplemental Investment Program, which has a total investment requirement of P20,476,916.89, covers the Fourth Tranche of Salary Increase of city government officials and employees from January 2019 to December 2019;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
