PROVINCIAL RESOLUTION NO. 349-2020

APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2020

WHEREAS, in pursuance to the Department of Energy Circular No. 2020-04-0008 Rationalizing the Utilization of ER 1-94 Funds by Local Government Units in Response to COVID-19 Public Health Emergency, the Province of Pangasinan has signified its intention to use whatever available amount under the said Fund, particularly the Electrification Funds for the said purpose;

WHEREAS, hence, presented for consideration is the Supplemental Investment Program No. 2 of the Province of Pangasinan as endorsed by the Provincial Development Council thru PDC Execom Resolution No. 04-20;

WHEREAS, Supplemental Investment Program No. 2 contains other priority programs, projects and activities that are not included in the approved 2020 Provincial Annual Investment Program and Supplemental Annual Investment Program No. 1 of Pangasinan;

WHEREAS, the Supplemental Investment Program No. 2 shall cover programs, projects and activities necessary for the management of the effects of COVID-19 public health crisis in the Province;

WHEREAS, the **P82,466,000.00** total investment requirement of Supplemental Investment Program No. 2 shall be sourced from the share of the Province from the Energy Regulation (ER) 1-94 of the Department of Energy (DOE), which is provided to the province as a host community of energy generating facilities, by virtue of the said DOE Department Circular;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;
