PROVINCIAL RESOLUTION NO. 350-2020

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) FOR THE GRANT OF CALAMITY ASSISTANCE TO THE PROVINCE OF PANGASINAN THROUGH THE PANGASINAN PROVINCIAL HOSPITAL FOR COVID-19 CASES

WHEREAS, Republic Act 11469, otherwise known as Bayanihan We Heal as One Act, enjoins Government-Owned Controlled Corporations including Philippine Charity Sweepstakes Office (PCSO) to help and earmark funds for COVID-19 measures;

WHEREAS, in compliance to the said law, the PCSO shall grant calamity assistance to selected hospitals charged to its Charity Fund;

WHEREAS, the Provincial Government of Pangasinan, through the Pangasinan Provincial Hospital, shall be the partner of the PCSO in the implementation of the Program;

WHEREAS, a grant of **P1,000,000.00** Calamity Assistance shall be released by the PCSO to the Pangasinan Provincial Hospital to aid the said hospital in the management of COVID-19 public health emergency;

WHEREAS, the Calamity Assistance shall be used exclusively for the following services:

- a. Procurement of testing kits, reagents, medical/diagnostic equipment, Personal Protective Equipment (PPE), and medicines to be used for the management of COVID-19 cases; and
- b. Cover the cost of laboratory/diagnostic procedures, and confinement of COVID-19 patients (except room charges and professional fees).

WHEREAS, the duties and responsibilities of the parties including other conditions are stipulated in the Memorandum of Agreement which is made an integral part of this resolution;


WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed a Memorandum of Agreement between the Province of Pangasinan, represented by Honorable Governor Amado I. Espino III, and the Philippine Charity Sweepstakes Office, represented by its Vice Chairperson and General Manager, Ms. Royina M. Garma;

NOW, THEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan of Pangasinan to authorize, as he is hereby authorized, the Provincial Governor, Amado I. Espino III, to enter into and sign a Memorandum of Agreement with the Philippine Charity Sweepstakes Office (PCSO) for the grant of Calamity Assistance to the Province of Pangasinan through the Pangasinan Provincial Hospital for COVID-19 cases;

RESOLVED, FINALLY, that copies of this resolution be furnished to Honorable Governor Amado I. Espino III, Province of Pangasinan, Vice Chairperson and General Manager, Ms. Royina M. Garma, Philippine Charity Sweepstakes Office, and the Pangasinan Provincial Hospital, for their information and guidance.
