RESOLUTION NO. 350-2022

DECLARING ORDINANCE NO. 173, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED “AN ORDINANCE ABOLISHING THE POSITION OF SENIOR BOOKKEEPER (SG 9) IN THE OFFICE OF THE MUNICIPAL ACCOUNTANT OF THE LOCAL GOVERNMENT UNIT OF BASISTA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 173, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 173, S-2021 of the Sangguniang Bayan of Basista, Pangasinan, entitled “An Ordinance abolishing the position of Senior Bookkeeper (SG 9) in the Office of the Municipal Accountant of the Local Government Unit of Basista, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;






