**APPROVING RESOLUTION NO. 19-004 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1 FOR CALENDAR YEAR 2019 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN”**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 19-004 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos, Pangasinan has prepared the city’s Supplemental Investment Program No. 1 for CY 2019. This was endorsed thru CDC Resolution No. 01-19 dated January 22, 2019 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 19-004 dated February 11, 2019;

**WHEREAS**, the Supplemental Investment Program, which has a total investment requirement of P944,690.91, covers the project/s of the LGU, which is the “Improvement of New Public Market (Phases V and VI)” in the amount of P430,216.20 and P514,474.71, respectively. Said projects are part of the details of the LGU’s major program, “Repairs and Maintenance of Government Facilities”, which is already included in the CY 2019 Annual Investment Program and with approved funding;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
