DECLARING ORDINANCE NO. 09-2021 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE ABOLISHING THE POSITION OF HUMAN RESOURCE MANAGEMENT OFFICER V (SG-24) IN THE HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE OF SAN JACINTO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
