**PROVINCIAL RESOLUTION NO. 352-2020**

**STRONGLY URGING PRESIDENT RODRIGO ROA DUTERTE THROUGH THE DEPARTMENT OF HEALTH (DOH) TO INITIATE AND ESTABLISH A DEDICATED HEALTH FACILITY FROM ONE OF THE DEPARTMENT OF HEALTH RETAINED HOSPITALS IN REGION 1 AS COVID-19 REFERRAL CENTER**

**WHEREAS**, the Department of Health (DOH) has been lately designating COVID-19 referral centers in some areas like the Philippine General Hospital, due to the increasing number of challenges posed by the COVID-19 pandemic in the country;

**WHEREAS**, the Province of Pangasinan recognizes this important move of the DOH by centralizing all efforts and resources into one or more COVID-19 referral centers that are fully equipped with manpower, medical equipment and fund allocations;

**WHEREAS**, as of April 8, 2020, the number of confirmed cases of COVID-19 in Region 1 is still steadily climbing;

**WHEREAS**, the establishment also of a dedicated health facility in Region 1 as COVID-19 referral center will help in the decongestion of other medical facilities and for a unified and systematic management of Patients Under Investigation (PUI);

**WHEREAS**, the Province of Pangasinan fully supports the establishment of a dedicated health facility in Region 1 as a means to help curb the spread of the disease in the Region;


