#### **RESOLUTION NO. 353-2019**

DECLARING MUNICIPAL ORDINANCE NO. 03-2019 OF THE SANGGUNIANG **BAYAN** OF MANAOAG, "AN PANGASINAN, **ENTITLED ORDINANCE** RECLASSIFYING THE 2,000 SQ. M. LOT OWNED BY MR. PABLO A. CENTINO II MARRIED TO NICOLE A. CENTINO LOCATED AT BARANGAY CABANBANAN, MANAOAG, PANGASINAN FROM AGRICULTURAL LOT TO COMMERCIAL LOT PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, however, the Sangguniang Bayan shall consider the observations raised by the Provincial Planning and Development Officer in her opinion dated March 8, 2019 in compliance with Memorandum Circular No. 54, Section 2 (b), and the Provincial Legal Officer in her opinion dated March 7, 2019, both as attached in this Resolution;
