PROVINCIAL RESOLUTION NO. 353-2021

ENJOINING ALL LOCAL GOVERNMENT UNITS OF THE PROVINCE OF PANGASINAN TO BE CONFORMABLE AND COMPLIANT WITH THE GUIDELINES OF THE PROVINCIAL INTER-AGENCY TASK FORCE, PROVINCIAL DIRECTIVES AND MEASURES FOR AN ORDERLY DISPOSITION SPECIFICALLY IN THE MANAGEMENT OF COVID-19

WHEREAS, the Local Government Code mandates local government units to exercise local autonomy and to ensure the general welfare of the people particularly in the promotion of their health and safety;

WHEREAS, during this period of public health crisis, local government units are always in the forefront of the battle to curb the transmission of COVID-19;


WHEREAS, it is the aim of the Sangguniang Panlalawigan to foster a good working relationship with all the local government units under the jurisdiction of the Province;

NOW, THEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


