PROVINCIAL RESOLUTION NO. 354-2020

AUTHORIZING THE USE OF UNEXPENDED LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND BALANCES OF CALENDAR YEARS 2015-2019 UNDER TRUST FUND FOR COVID EXPENSES AND APPROVING THE 2ND REVISED ANNUAL INVESTMENT PROGRAM (AIP) OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2020

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the 2nd Revised Annual Investment Program (AIP) of the Province of Pangasinan for CY 2020 as endorsed by the Provincial Development Council thru PDC Execom Resolution No. 05-20;

WHEREAS, the Revised AIP CY 2020 of the Province of Pangasinan was approved by the Sangguniang Panlalawigan on December 6, 2019 through Provincial Resolution No. 703-2019 to accommodate projects which are deemed necessary in the development of the Province;

WHEREAS, there is again a need, however, to amend the Revised AIP to include programs, projects and activities to augment the existing resources of the Province in responding to the COVID-19 pandemic crisis to be funded by the Trust Fund from the unexpended Local Disaster Risk Reduction and Management Fund (LDRRMF) for CYs 2015 to 2019 in the amount of P193,855,868.22;

WHEREAS, said new programs, projects and activities are in accordance with Section 2.5.6 of Local Budget Circular No. 124 dated March 26, 2020;

WHEREAS, the said 2nd Revised AIP also includes programs, projects, and activities in response to the crisis brought about by the COVID-19 pandemic, which will be funded by the Bayanihan Grant to Provinces (BGP) of the Department of Budget and Management with a total allocation of P162,233,926.00 in pursuance to Section 3.5 of Local Budget Circular No. 126 dated April 13, 2020;


WHEREAS, after a careful study of the said Revised AIP, this august Body finds it to be in order;

WHEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


