**DECLARING ORDINANCE NO. 12-2021 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE POSITION OF THREE (3) ADMINISTRATIVE AIDE I (UTILITY WORKER I) (SG-1) AND APPROPRIATING FUNDS THEREOF UNDER THE MAYOR’S OFFICE OF SAN JACINTO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**


