PROVINCIAL RESOLUTION NO. 355-2022

INVITING THE PROVINCIAL HEALTH OFFICER, PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER AND THE PROVINCIAL DIRECTOR OF THE PHILIPPINE NATIONAL POLICE, ALL OF THE PROVINCIAL INTER-AGENCY TASK FORCE (IATF); AND REPRESENTATIVES FROM THE DEPARTMENT OF HEALTH TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS MARCH 14, 2022 REGULAR (PHYSICAL) SESSION TO UPDATE THE BODY ON THE STATUS OF COVID-19 IN THE PROVINCE

WHEREAS, most provinces in the country including Pangasinan are now placed under Alert Level 1 due to the lessening of COVID-19 cases;

WHEREAS, for the last weeks, some parts of the Province of Pangasinan have been recording zero active infections;

WHEREAS, at present, normalcy has started to be back on the lives of everyone amid the public health crisis as compared to the days when the Province has experienced a sudden increase of COVID-19 cases due to Omicron wave;

WHEREAS, the Sangguniang Panlalawigan expresses concern whether or not Pangasinan is now ready for more relaxed restrictions under Alert Level 1 particularly in the conduct of social gatherings;

WHEREAS, this prompted the Sangguniang Panlalawigan to schedule again a Question Hour and invite the Members of the Provincial Inter-Agency Task Force (IATF) and this time representatives from the Department of Health to shed light on the current situation of COVID-19 in the Province and the present direction of the Province towards further eliminating the disease;



WHEREFORE, in view of the foregoing, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


