DECLARING MUNICIPAL ORDINANCE NO. 2019-121 OF THE SANGGUNIANG BAYAN OF MANGALDAN. PANGASINAN, ENTITLED "AN ORDINANCE DECLARING AS UNLAWFUL ACTS AND CONDUCTS OF **DISCRIMINATION AGAINST PERSONS WITH DIVERSE** SEXUAL ORIENTATION, GENDER IDENTITY AND GENDER EXPRESSION (SOGIE) WITHIN THE MUNICIPALITY OF MANGALDAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Municipal Ordinance No. 2019-121 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) of RA 7160; 1987 Philippine Constitution and Article 2 of the Universal Declaration of Human Rights;

WHEREAS, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer stated in her opinion dated March 15, 2019, as attached in this Resolution;
