APPROVING RESOLUTION NO. 2022-434 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “CONCURRING/APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 02, SERIES OF 2022, ENTITLED “ADOPTION OF RESOLUTION ENDORSING THE REVISED FIVE PERCENT (5%) LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN (LDRRMFIP) OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN CALENDAR YEAR 2022, AND ENDORSING IT TO THE SANGGUNIANG BAYAN FOR APPROVAL”

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2022-434 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Local Risk Reduction and Management Fund Investment Plan (LDRRMFIP) CY 2022. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 02, Series of 2022, dated January 10, 2022;

2. The LGU revised their LDRRMFIP for CY 2022 to include the Unexpended Balance from their LDRRM Fund for CY 2021 amounting to P1,984,139.38 programmed for the procurement of food and non-food items for COVID-19 emergency response; and
3. The LDRRMFIP is supported by LDRRM Council Resolution No. 22-01, Series of 2022.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;
