RESOLUTION NO. 357-2020

APPROVING RESOLUTION NO. 2020-36 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 1, CY 2020 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2020-36 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Mangaldan, Pangasinan has prepared the municipality’s Supplemental Annual Investment Program No. 1 for CY 2020. This was endorsed by the Council, through MDC Resolution No. 1, Series of 2020 dated February 17, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2020-36 dated February 21, 2020;

WHEREAS, said Supplemental AIP which has a total investment requirement of P3,222,429.32 is intended to finance the implementation of the Modified Salary Schedule for Local Government Personnel (First Tranche) Pursuant to Local Budget Circular No. 121 dated February 24, 2020 for the municipal employees of Mangaldan;

WHEREAS, funding for this Supplemental AIP is embodied in the Supplemental Budget No. 1, FY 2020, and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2020-01 dated February 21, 2020;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
