APPROVING RESOLUTION NO. 2022-435 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “CONCURRING/APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 03, SERIES OF 2022, ENTITLED “ADOPTION OF RESOLUTION ENDORSING THE REVISED ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN CALENDAR YEAR 2022, AND ENDORSING IT TO THE SANGGUNIANG BAYAN FOR APPROVAL”

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2022-435 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan proposed for the revision of their Annual Investment Program (AIP) for CY 2022. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 03, Series of 2022, dated January 19, 2022, to the Sangguniang Bayan for approval;

2. The LGU revised their AIP for CY 2022 to cover the changes in the Revised Local Disaster Risk Reduction and Management Fund Investment Plan for CY 2022, which include the additional sum of P1,984,439.38 from the Unexpended Balances of LDRRMF for CY 2021 programmed for COVID-19 response; and
3. The preparation of the Revised AIP is in pursuance to Sections 6.4 and 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, which states:

Section 6.4 The unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the Local Disaster Risk Reduction and Management Council (LDRRMC) within the next five (5) years.

Section 6.5 The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a Revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2022-435 of the Sangguniang Bayan of Sta. Barbara, Pangasinan, entitled, “Concurring/Approving Municipal Development Council (MDC) Resolution No. 03, Series of 2022, entitled “Adoption of Resolution Endorsing the Revised Annual Investment Program of the Municipality of Sta. Barbara, Pangasinan Calendar Year 2022, and endorsing it to the Sangguniang Bayan for approval”;


