**APPROVING RESOLUTION NO. 554, S-2019-22 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 10 OF THE CITY URDANETA FOR CY 2021 IN THE AMOUNT OF TEN MILLION ONE HUNDRED THOUSAND PESOS ONLY (P10,100,000.00)”**

**WHEREAS**, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Resolution No. 554, S-2019-22 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Urdaneta, Pangasinan had identified items in their Supplemental Investment Program No. 10 for CY 2021. This was endorsed by the Local Development Council to the Sangguniang Panlungsod on September 17, 2021 by the City Development Council through Resolution No. 9-2021; and
2. The Supplemental Investment Program No. 10 for CY 2021 of the City covers the implementation of Anti-COVID 19 related programs and projects - Rice Relief Assistance.




