**C E R T I F I C A T I O N**

TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the special session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on March 23, 1994 at Lingayen, Pangasinan, the following Provincial Ordinance was approved:

**PROVINCIAL ORDINANCE NO. 36**

**DECLARING ALL THE VETOED ITEMS OF THE SPECIAL PROVISIONS OF THE ANNUAL BUDGET FOR CALENDAR YEAR 1994 OF THE PROVINCE OF PANGASINAN EFFECTIVE AND OPERATIVE**

Be it enacted by the Sangguniang Panlalawigan in session assembled that:

SECTION 1. The following sections of the Annual Budget for Calendar Year 1994 of the Province of Pangasinan vetoed by the Provincial Governor are hereby reenacted:

a) Section 4 (a) of the Special Provisions

The balance in all appropriations for the (1) Office of the Provincial Governor and the Sangguniang Panlalawigan (2) Development Fund and (3) Non-Office appropriations in the the Annual Budget of last calendar year cannot be re-appropriated for the same purpose without the prior approval of the Sangguniang Panlalawigan;

b) Section 4 (c) of the Special Provisions

The allocations for Community Projects under the Development Fund and Repair of Schools and Community Projects under Non-Office shall be allocated by the Governor on the one hand, and by the Vice Governor and the Sangguniang Panlalawigan Members on the other, on the basis of a fifty-fifty (50:50) sharing wherein fifty percent (50%) of the amounts appropriated for the above-mentioned items shall be allocated by the Governor while the remaining fifty percent (50%) shall be allocated by the Vice Governor and the Sangguniang Panlalawigan Members, provided, that the Governor may, by Executive Order give the Vice Governor the authority to approve allocations corresponding to the Sangguniang Panlalawigan Members;

c) Section 4 (h) of the Special Provisions

Upon request of the Office or Department Head, the Provincial Governor may augment by an ordinance, any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

d) Section 4 (j) of the Special Provisions

No portion of the amount appropriated for travel and transportation shall be expended for travel outside the province by any official or employee, including the Provincial Auditor, unless express authority in writing extended by the Governor or Vice Governor in appropriate instances is previously obtained;

e) Section 4 (k) of the Special Provisions

No vacant positions, nor new ones, shall be filled without express approval of the Governor or the Vice Governor in appropriate cases and the issuance of a corresponding appointment therefor;

The Personnel Selection Board (PSB) of the Province shall however determine the qualifications and fitness of applicants subject to the Civil Service rules on the matter;

On the matter of filling of new and vacant positions, the recommendation of the Vice Governor or the Sangguniang Panlalawigan Members shall be given credence or consideration specially when the same comes from the district of the Sangguniang Panlalawigan Members concerned;


f) Section 4 (l) of the Special Provisions


Whenever in his judgement, the public interest requires, the Governor or the Vice Governor in appropriate cases is hereby authorized to suspend or otherwise stop the expenditures of any amount herein appropriated or any items for any purposes, except those for salaries of positions with incumbent possessing valid appointment to their respective positions;

SECTION 2. Any provision/s of the 1994 Annual Budget contrary to the reenacted provision/s is/are hereby declared null and void;

SECTION 3. EFFECTIVITY. These reenacted provisions are deemed effective as of January 1, 1994.
