APPROVING RESOLUTION NO. 52, S-2020 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "APPROVING THE QUICK RESPONSE FUND FROM 2013-2019 OF THE 5% LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND THE REVISED CY 2020 ANNUAL INVESTMENT PLAN IN THE AMOUNT OF TEN MILLION FIVE HUNDRED SEVENTY FOUR THOUSAND FIVE HUNDRED FORTY-EIGHT PESOS AND THIRTEEN CENTAVOS (P10,574,548.13) OF THE MUNICIPALITY OF VILLASIS, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 52, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Villasis, Pangasinan has revised their CY 2020 Annual Investment Program of the municipality to include the programs/projects to be funded from the Quick Response Fund from 2013-2019 of the LDRRMF. This was endorsed to the Sangguniang Bayan for approval thru MDC Executive Committee Resolution No. 07-2020 dated October 28, 2020;

WHEREAS, on November 17, 2020, the Sangguniang Bayan approved the Revised Annual Investment Program through Resolution No. 52, S-2020. This is in accordance with Item 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 and Item 2.5.6 of Local Budget Circular No. 124 dated March 26, 2020;

WHEREAS, the Revised AIP CY 2020 has a total investment requirement of P234,611,624.00 as compared to the approved AIP 2020 (P224,036,700.00) due to integration of programs/projects/activities to be funded by the 30% QRF CY 2013-2019 amounting to P10,574,548.13;

WHEREAS, the programs/projects to be funded from the unexpended balance of DRRMF for CY 2015-2019 are emergency measures to respond to crisis brought about by Covid-19 pandemic. This is in accordance to Local Budget Circular No. 124 dated March 26, 2020;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all existing laws, rules and regulations shall be the responsibility of the Municipal Government of Villasis;


