RESOLUTION NO. 362-2021

APPROVING RESOLUTION NO. 215, S-2021 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PLAN FOR CY-2021 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF P233,409,854.00 FROM THE GENERAL FUND AND P3,885,000.00 FROM THE ECONOMIC ENTERPRISE"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 215, Series of 2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Municipal Development Council of San Fabian, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2021. This was endorsed by the Council to the Sangguniang Bayan on October 19, 2020 through MDC Resolution No. 08, S-2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of San Fabian, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for

the operations of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction programs, projects, and activities, and d) activities in pursuance of the objectives of GAD of the LGU. Also attached to the AIP, among others, are the following: a) List of Priority to be funded by External Sources, b) Local Climate Change Action Plan, c) Peace and Order Plan, d) list of PPAs for the Local Council for the Protection of Children, e) list of PPAs for Senior Citizens and Persons with Disabilities, f) list of PPAs to combat Acquired Immune Deficiency Syndrome (AIDS), g) list of PPAs to address problems on illegal drugs, h) Local Nutrition Action Plan, and i) Annual Cultural Development Plan;

WHEREAS, the AIP contains programs, projects and activities which will be funded by the LGU in the amount of P233,409,854.00 for the General Fund and P3,885,000.00 from the Economic Enterprise Income, as embodied in their 2021 Annual Budget which was passed and approved by their Sangguniang Bayan on December 14, 2020 through Appropriation Ordinance No. 06, S-2020. It also includes proposed programs and projects to be funded from the LGU share in the Excise tax (CY 2017) and Local Government Support Fund-Financial Assistance of the National Government;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGU's IRA (P219,749,854.00), amounting to P43,949,970.80 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% Development Fund conforms with the Joint DBM-DILG Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "*Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects*". However, the municipality shall specify in the Annual Investment Program the details under "*Various Small Scale Development Projects at Various Barangays*" and "*Covid-19 Rehabilitation Program*";

WHEREAS, the programs and projects included in the Municipal Disaster Risk Reduction and Management Fund Plan, amounting to P11,670,492.70, were based on Section 21 of RA 10121 and Memorandum Circular No. 2013-1 of the NDRRMC, DBM and DILG dated March 25, 2013 (*Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund*). However, the LDRRM Plan of the municipality shall still be submitted to the Office of Civil Defense (OCD) for review as per Local Budget Memorandum No. 77, dated May 15, 2018;

WHEREAS, the LGU had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;




