## **RESOLUTION NO. 363-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 2017-06 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "OTHERWISE KNOWN AS THE 2018 REVENUE CODE OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Municipal Ordinance No. 2017-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and Provincial Treasurer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 129 and 132 of RA 7160;

**WHEREAS**, however, the Sangguniang Bayan shall consider the points raised by the Provincial Legal Officer in her opinion dated March 11, 2019 (which were not yet addressed by the Sangguniang Bayan), Observation No. 2 of the Provincial Treasurer in her opinion dated April 22, 2019, both attached in this Resolution;

**WHEREAS**, subject ordinance shall take effect after all the legal requirements of public hearing, posting and publication pursuant to RA 7160 are complied with;


