APPROVING RESOLUTION NO. 12, S-2020 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE FIRST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 12, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Infanta, Pangasinan had identified items in their First Supplemental Investment Program for CY 2020 with a total investment requirement of P3,725,211.31. This was endorsed to the Sangguniang Bayan for approval on February 19, 2020 MDC Resolution No. 1, S-2020 and was favorably acted upon by the Sangguniang Bayan on March 2, 2020 thru SB Resolution No. 12, S-2020;

WHEREAS, the First Supplemental Investment Program of the municipality covers the fund augmentation for the personal services of all offices and maintenance and other operating expenses for some municipal offices;

WHEREAS, funding for the full implementation of this Supplemental Investment Program is embodied in their proposed Supplemental Budget No. 01 Calendar Year 2020 which was approved and enacted by their Sangguniang Bayan on March 2, 2020 thru Appropriation Ordinance No. 01, S-2020;
