**APPROVING RESOLUTION NO. 22-09 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2022-1 EMBODYING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1 FOR FY 2022 OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Resolution No. 22-09 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. On January 31, 2022, the Local Development Council of Sta. Maria, Pangasinan has identified programs/projects to be funded from the CYs 2018 and 2019 municipality's share from Tobacco Excise Tax. These are embodied in the Supplemental Investment Program (SAIP) No. 1 of Sta. Maria, Pangasinan which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 2022-1;

2. The Supplemental Investment Program No. 1 with a total investment requirement amounting to Php8,789,235.00 covers the implementation of development projects (Concreting/Rehabilitation of various Local Access Roads in the barangays) that are consistent with Local Budget Memorandum Nos. 83 & 84, both dated November 22, 2021; and
3. On February 15, 2022, the Sangguniang Bayan enacted Supplemental Budget No. 1 through Appropriation Ordinance No. 22-1 to support the implementation of the said Supplemental Investment Program No. 1 of the municipality.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Maria, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—


