APPROVING RESOLUTION NO. 50, SERIES OF 2020 OF THE MUNICIPALITY OF BINMALEY, PANGASINAN, ENTITLED “RESOLUTION STRONGLY ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) RESOLUTION NO. 01, SERIES OF 2020, ENTITLED RESOLUTION RECOMMENDING THE UTILIZATION OF ELEVEN MILLION THIRTEEN THOUSAND EIGHT HUNDRED NINETY THREE PESOS AND NINETY-SEVEN CENTAVOS (Php11,013,893.97) FROM THE MDRRMF TRUST FUND”

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 50, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Disaster Risk Reduction and Management Council of Binmaley, Pangasinan revised the LGU’s Municipal Risk Reduction and Management Fund Investment Plan CY 2020 thru MDRRMC Resolution No. 01, Series of 2020 to include the programs, projects and activities proposed to be funded by the LGU’s unexpended LDRRM Fund CYs 2016 to 2019 Trust Funds in the amount of P11,013,893.97, purposely to undertake measures to combat the threats of COVID-19 in the municipality. This was favorably acted upon by the Sangguniang Bayan of Binmaley thru SB Resolution No. 50, Series of 2020;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
