APPROVING RESOLUTION NO. 167-2020 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM FOR CY 2020 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its Resolution No. 167-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Mangatarem, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program CY 2020 on April 17, 2020 thru MDC Resolution No. 05, S-2020. This was favorably acted upon by the Sangguniang Bayan on April 20, 2020 thru SB Resolution No. 167-2020;

WHEREAS, the 2020 AIP of the Municipality of Mangatarem was revised to integrate the Revised Local Risk Reduction and Management Fund Investment Plan (LDRRMFIP) prepared and endorsed by the LDRRM Council thru MDRRMC Resolution No. 02, S-2020. The LDRRMFIP includes programs, projects and activities (PPAs) in response to the crisis due to COVID-19 pandemic, which were proposed to be funded by the municipality's unexpended balances of their LDRRMF CYs 2017-2019 Trust Fund in the amount of P18,029,000.00;
