RESOLUTION NO. 370-2020

DECLARING MUNICIPAL ORDINANCE NO. 88, S-2020 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY USE OF FACE MASKS AND STRINGENT PRACTICE OF PHYSICAL DISTANCING BY ALL PERSONS WHO ARE FOUND IN THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN DURING THE EXTREME ENHANCED COMMUNITY QUARANTINE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 88, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to General Welfare Clause of Section 16 of RA 7160; Section 447 (a) (1) (iii); and DILG Memorandum Circular No. 2020-071 Re: Mandatory Wearing of Face Masks or Other Protective Equipment in Public dated April 9, 2020;

WHEREAS, the LGU shall observe the provision of Article 417 (b) of the Implementing Rules and Regulations of RA 7160 in the implementation of the subject ordinance;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with all the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
