**RESOLUTION NO. 372-2022**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2022 OF THE CITY OF ALAMINOS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P30,577,976.00, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2022 involving total appropriations of P30,577,976.00, which was enacted on February 15, 2022 through Appropriation Ordinance No. 2022-01;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the full implementation of the Third Tranche Compensation for the newly created positions shall be subject to the provisions of Local Budget Circular No. 143 dated January 3, 2022 of the Department of Budget & Management;

2. That all appropriation for Public Affairs Fund shall be spent solely for public purposes and no amount shall be applied for religious or private purposes pursuant to Section 305 (b) and 335 of R.A. No. 7160, and shall be broken down into appropriate object of expenditures, as may be applicable, in accordance with the Revised Chart of Accounts for LGUs under COA Circular No. 2015-009 dated December 1, 2015;
3. That all programs, projects and activities shall be in accordance with the approved LDP and the Fiscal Year 2022 Supplemental Investment Program of the city formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
4. That the salary grade allocation of the new position shall be adjusted

to conform with the LFC opinion dated Jan. 21, 2022 of Ordinance No. 2021-32 of the Sangguniang Panlungsod of Alaminos City;

5. That the funding sources for the subject supplemental budget were determined in accordance with the provisions of Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993; and
6. That the appropriation for the grant of Performance Based Bonus (PBB) shall only be disbursed upon issuance of circular granting the same.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;


