#### **PROVINCIAL RESOLUTION NO. 373-2019**

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO, III, TO NEGOTIATE AND ENTER INTO A LOAN AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES IN THE AMOUNT OF NINE HUNDRED FIFTY MILLION PESOS (P950 MILLION) UNDER THE TERMS AND CONDITIONS OF THE OMNIBUS TERM LOAN FACILITY (CREDIT LINE)

**WHEREAS**, it is the main objective of the Provincial Government of Pangasinan to generate and maximize the use of its resources and revenues for the development plans, program objectives and priority projects of the Province;

WHEREAS, the Provincial Government of Pangasinan would like to ensure the delivery of basic services and the provision of adequate facilities not only to the people living in the urban areas but also to the countryside;

WHEREAS, due to budgetary constraints, the province cannot possibly prosecute the proposed new projects as scheduled and listed in the annual investment program of the Province;

WHEREAS, the provincial government of Pangasinan will now avail of the Omnibus Term Loan Facility (Credit Line) with the Land Bank of the Philippines in the amount of Nine Hundred Fifty Million Pesos (P950 Million) to finance the following strategic programs and projects of the Province, to wit:

- 1. Construction of the Pangasinan Convention and Multi-Purpose Center (Phase II)
- 2. Procurement of Hospital Equipment
- 3. Procurement of Heavy and Light Equipment
- 4. Construction of Various Government Buildings and Facilities
- 5. Paving of Roads and Pathwalks, and Reconstruction of Bridges

Espino III, to negotiate and enter into a Loan Agreement with the Land Bank of the Philippines in the amount of Nine Hundred Fifty Million Pesos (P950 Million) under the terms and conditions of the Omnibus Term Loan Facility (Credit Line);
