PROVINCIAL RESOLUTION NO. 374-2020

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE BAGUIO GENERAL HOSPITAL AND MEDICAL CENTER FOR THE LATTER TO PERFORM TESTING FOR COVID-19 (SARS-CoV-2) SPECIMEN COLLECTED BY THE PROVINCE OF PANGASINAN THROUGH REALTIME RT-PCR

WHEREAS, Pangasinan does not have its own facility to perform testing for COVID-19 (SARS-CoV-2) for its constituents;

WHEREAS, Pangasinan is geographically located near Baguio General Hospital and Medical Center and the latter has agreed to perform the testing for COVID-19 (SARS-CoV-2) specimen through Realtime RT-PCR for the Province;

WHEREAS, as such, Baguio General Hospital and Medical Center shall be entitled to and file claims and reimbursements from Philhealth relative to all tests performed by it pursuant to Philhealth Circular No. 2020-0010;

WHEREAS, the obligations of both parties including other conditions are stipulated in the Memorandum of Agreement which is made an integral part of this resolution;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed a Memorandum of Agreement between the Province of Pangasinan, represented by Honorable Governor Amado I. Espino III, and the Baguio General Hospital and Medical Center, represented by its Medical Chief Center II, Dr. Ricardo B. Runez, Jr.;

WHEREFORE, in view of the foregoing, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –
