RESOLUTION NO. 375-2021

APPROVING RESOLUTION NO. 19-2021 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 01 FOR THE CALENDAR YEAR 2021 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Resolution No. 19-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Burgos, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on March 02, 2021 by the Municipal Development Council through MDC Resolution No. 2021-001;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of development projects and disaster risk reduction programs/activities;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P9,500,000.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 01-2020 in the amount of P5,500,000.00, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, S-2021 on March 10, 2021 and approved by the Municipal Mayor on March 18, 2021 and the remaining P4,000,000.00 is proposed to be funded by the national government through the Local Government Support Fund;


