**RESOLUTION NO. 376-2007**

**DECLARING THE SUPPLEMENTAL BUDGET NO.  
4 FOR CALENDAR YEAR 2007 OF SUAL,  
PANGASINAN OPERATIVE**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Supplemental Budget No. 4 for Calendar Year 2007 involving total appropriations of P31,548,894.63 which was approved on October 3, 2007 through Appropriation Ordinance No. 5;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The disbursement of appropriation for economic development projects shall be in accordance with the approved Annual Investment Plan of the municipality;

2. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act);

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality;

**NOW, THEREFORE**, in view of the foregoing, on motion of SP Members Danilo B. Dizon and Alicia J. Pulido, and co-sponsored by SP Members Amadeo T. Espino, Jolly R. Resuello and Raul P. Sison, duly seconded, it was –

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE the Supplemental Budget No. 4 for Calendar Year 2007 of Sual, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Sual and shall serve as basis for auditing purposes of the Commission on Audit;

**RESOLVED, FINALLY**, that copies of this resolution be furnished the Municipal Budget Officer of Sual, Pangasinan and the Provincial Auditor's Office, for their information and guidance.
