RESOLUTION NO. 378-2020

DECLARING ORDINANCE NO. 04, S-2020 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE PLANTILLA POSITION OF MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (PUBLIC EMPLOYMENT SERVICE OFFICE MANAGER) IN THE MUNICIPALITY OF INFANTA, PROVINCE OF PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Ordinance No. 04, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 76 and Section 447 (a) (1) (viii) of RA 7160;

WHEREAS, however, to conform with the Qualification Standards issued by the Civil Service Commission, the following should be adjusted:
