### **RESOLUTION NO. 38-2021**

#### APPROVING RESOLUTION NO. 122, S-2020 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE SIXTH SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 122, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Infanta, Pangasinan had identified items in their Supplemental Investment Program No. 6 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on December 1, 2020 by the Municipal Development Council through MDC Resolution No. 7, S-2020;

WHEREAS, the Supplemental Investment Program No. 6 of the municipality covers fund augmentation for the Personal Services (Special Risk Allowance), Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices;

WHEREAS, the Supplemental Investment Program No. 6 has an investment requirement of P3,561,646.72. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 06 for CY 2020, which was passed and approved by their Sangguniang Bayan on December 7, 2020 thru Appropriation Ordinance No. 07, S-2020;
