RESOLUTION NO. 381-2020

DECLARING ORDINANCE NO. 04-2020 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “AN ORDINANCE CREATING FOUR (4) PLANTILLA POSITIONS UNDER THE OFFICE OF THE MAYOR: ENVIRONMENTAL MANAGEMENT SPECIALIST I, SALARY GRADE 11; TOURISM OPERATIONS ASSISTANT, SALARY GRADE 7; POPULATION DEVELOPMENT OFFICER II, SALARY GRADE 15 AND LIBRARIAN I, SALARY GRADE 7” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 04-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of RA 7160;

WHEREAS, however, the position title of Population Development Officer II, SG-15, should be changed to Population Program Officer III, SG-15, to conform with the Index of Occupation Services, Position Titles and Salary Grade of LGUs and Budget Circular No. 2004-3 dated March 6, 2004 entitled “Conversion of Positions Performing Staff/Non-Technical Functions”;

WHEREAS, however, the salaries and other benefits of the position of Tourism Operations Assistant, SG-17 and Environmental Specialist, SG-11 should be appropriated in a Supplemental Budget of the municipality;




