RESOLUTION NO. 382-2020

DECLARING ORDINANCE NO. 05-2020 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “AN ORDINANCE CREATING PLANTILLA POSITIONS UNDER THE OFFICE OF THE MUNICIPAL TREASURER: MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (ASSISTANT MUNICIPAL TREASURER), SALARY GRADE 22; REVENUE COLLECTION CLERK III, SALARY GRADE 9 AND LIAISON AIDE, SALARY GRADE 4” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 05-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of RA 7160;

WHEREAS, however, the position title of Liaison Aide, SG-4, should be changed to Administrative Aide, SG-4, to conform with the Index of Occupation Services, Position Titles and Salary Grade of LGUs and Budget Circular No. 2004-3 dated March 6, 2004 entitled “Conversion of Positions Performing Staff/Non-Technical Functions”;

WHEREAS, however, the salaries and other benefits of the position of Revenue Collection Clerk III, SG-9 should be appropriated in a Supplemental Budget of the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –




