#### **PROVINCIAL RESOLUTION NO. 383-2019**

AUTHORIZING THE PROVINCIAL VICE GOVERNOR TO BE THE OFFICIAL SIGNATORY OF THE SANGGUNIANG PANLALAWIGAN OF PANGASINAN WITH THE LAND BANK OF THE PHILIPPINES

WHEREAS, the Land Bank of the Philippines is one of the authorized government depository banks of the Provincial Government of Pangasinan;

**WHEREAS**, the Vice Governor will serve the Province under a fresh mandate and therefore be the signatory of the transactions of the Sangguniang Panlalawigan with the said bank;

WHEREAS, under Section 466, par.(a) (1) of the Local Government Code of 1991 provides that the Vice Governor shall "be the presiding officer of the sangguniang panlalawigan and sign all warrants drawn on the provincial treasury for all expenditures appropriated for the operation of the sangguniang Panlalawigan";

**WHEREAS**, it is necessary therefore to authorize the Provincial Vice Governor to be the official signatory of the Sangguniang Panlalawigan with Land Bank of the Philippines in order to have uninterrupted transactions with the same;

**NOW THEREFORE,** on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was -

**RESOLVED,** by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Vice Governor to be the official signatory of the Sangguniang Panlalawigan of Pangasinan with the Land Bank of the Philippines;
