APPROVING RESOLUTION NO. 10, S-2021 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED “APPROVING THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPAL SUPPLEMENTAL BUDGET NO. 1, S-2021 OF THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Resolution No. 10, Series of 2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Quintin, Pangasinan has formulated and endorsed the municipality’s Supplemental Annual Investment Program (SAIP) No. 1 thru MDC Resolution No. 1, S-2020 dated February 26, 2021 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Annual Investment Program No. 1 with an investment requirement amounting to P18,806,592.35 covers the implementation of development projects and fund augmentation for DRRM activities, and personal services, maintenance and other operating expenses of offices in the LGU;

WHEREAS, this is supported by the Supplemental Budget No. 1 which was enacted and approved by the Sangguniang Bayan on March 15, 2021 Appropriation Ordinance No. 6, S-2021;


