RESOLUTION NO. 386-2022

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2022 OF SAN NICOLAS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P245,086,341.00, OPERATIVE IN PART

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Annual Budget for Calendar Year 2022 involving total appropriations of P245,086,341.00, which was enacted on November 15, 2021 through Appropriation Ordinance No. 02, Series of 2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the full implementation of the Third Tranche compensation adjustment for municipal officials and employees shall be subject to the provisions of Local Budget Circular No. 143 dated January 3, 2022 of the Department of Budget and Management; and the salaries of the following shall be adjusted;

2. That the grant of Step Increment of Christopher D. Serquina, Agricultural Technologist under the Municipal Agriculturist Office should be adjusted from SG 10/2-P241,656.00 to SG 10/3-P243,684.00;
3. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A No. 10121 known as the as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the Department of Budget and Management - National Disaster Risk Reduction and Management Council - Department of the Interior and Local Government (DILG) Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);
4. That all procurement to be undertaken shall be subject to the provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
5. That all programs, projects and activities shall be accordance with the approved Local Development Plan and the FY 2022 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
6. That the projects under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re: Revised Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects;

That the appropriation for devolved functions and services should be provided in FY 2022 pursuant to the provisions of Executive Order No. 138 dated June 1, 2021 and DILG-DBM Joint Memorandum Circular No. 2021-1 dated August 11, 2021 and shall be consistent with the Devolution Transition Plan of the Municipality;
8. That all appropriation for Public Affairs Fund under the Special Purpose Appropriation be spent solely for public purposes and no amount shall be applied for religious or provide purposes pursuant to Section 305 (b) of R.A 7160 & shall be broken down into appropriate objects of expenditures, as may be applicable in accordance with the New Government Accounting System (NGAS');
9. That the position titles under Local Executive Offices of the Municipality should be changed to conform with the provisions of Local Budget Circular No. 137, dated July 13, 2021 entitled the "Index of Occupational Services, Position Titles & Salary Grades in the Local Government (IOS-LGU);
