PROVINCIAL RESOLUTION NO. 387-2022

INVITING THE PROVINCIAL AGRICULTURE OFFICE, OFFICE OF THE PROVINCIAL VETERINARY AND THE PANGASINAN EGG PRODUCERS' ASSOCIATION TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS MARCH 21, 2022 REGULAR SESSION TO UPDATE THE BODY ON THE STATUS OF EGG SUPPLY AS WELL AS ITS PRODUCTION AND PRICES IN THE PROVINCE OF PANGASINAN

WHEREAS, a lot of broiler raisers have shifted to layer poultry farming or chicken egg production amid the pandemic, pushing the supply higher to the detriment of the small producers;

WHEREAS, chicken egg production in the country has increased further and it has been started to raise concern for producers;

WHEREAS, reports have reached the Sangguniang Panlalawigan that local producers of egg in the Province of Pangasinan are now being affected with the problem because the produce coming from other areas outside of the province may have resulted to unreasonably reduction of egg prices;

WHEREAS, the Sangguniang Panlalawigan is also concerned that local producers of egg in the Province of Pangasinan may have encountered problems in disposing their own products;

WHEREAS, there is an urgent need to monitor the influx of eggs coming from the neighboring provinces of Pangasinan and check on the inspection or regulation fees being imposed on these products;

WHEREFORE, in view of the foregoing, on motion of SP Member Rosary Gracia P. Perez-Tababa, duly seconded, it was –


