PROVINCIAL RESOLUTION NO. 388-2019

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, the Provincial Government of Pangasinan is in need of a motor vehicle to be used for the delivery of basic extension services and technical assistance and other related programs and projects in the agricultural sector implemented in the Province;

WHEREAS, the Provincial Government of Pangasinan intends to buy one (1) unit of motor vehicle with a total amount of P1,166,000.00 to be charged to the Office of the Provincial Agriculturist-Capital Outlay (8711) funds, with the following specifications:
