DECLARING MUNICIPAL ORDINANCE NO. 82, S-2019 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE REDUCING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT FEE AND AMENDING ARTICLE H-"PERMIT FEES ON TRICYCLE OPERATION", SECTION 3H-02 "IMPOSITION OF FEES" OF THE REVENUE CODE OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
