PROVINCIAL RESOLUTION NO. 390-2022

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO PURCHASE A MOTOR VEHICLE FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, the Provincial Government of Pangasinan is in need of a motor vehicle which shall be used by the Provincial Social Welfare and Development Office as a means to coordinate with local government units and other agencies, rescue abused clients and distribute financial assistance;

WHEREAS, the Provincial Government of Pangasinan intends to purchase a motor vehicle with a total amount of P1,388,200.00 with the following specifications:

WHEREAS, the Provincial Government of Pangasinan shall comply with DILG Memorandum Circular No. 2014-155 dated December 17, 2014 which provides the "Guidelines on Motor Vehicles Acquisition by the Local Government Units" and DBM Budget Circular No. 2016-5 dated August 22, 2016 which "Revised the Guidelines on the Acquisition and Use of Government Motor Vehicles" in the procurement of the said vehicle;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to acquire said vehicle as a means to further enhance the health and medical services needed by the people;

NOW THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was -


