PROVINCIAL RESOLUTION NO. 391-2019

AMENDING RULE XI, SECTION 68 (h) OF THE INTERNAL RULES OF PROCEDURE OF THE 10TH SANGGUNIANG PANLALAWIGAN OF PANGASINAN (2019-2022) BY DELETING THE COMMITTEE ON GAMES AND AMUSEMENT

WHEREAS, pursuant to Rule XI, Section 68 (h) of the Internal Rules of Procedure of the 10th Sangguniang Panlalawigan of Pangasinan, twenty (20) standing committees are created to perform certain functions for the Sangguniang Panlalawigan;

WHEREAS, the Sangguniang Panlalawigan finds it proper to reduce the number of the standing committees to only nineteen;

WHEREAS, it is necessary therefore to amend Rule XI, Section 68 (h) of the Internal Rules of Procedure of the 10th Sangguniang Panlalawigan of Pangasinan by deleting the 20th committee which is the Committee on Games and Amusement, in charge of all matters directly and principally relating to all forms and places of gaming and amusements;

NOW THEREFORE, on motion of SP Member Nestor D. Reyes, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to amend, as it is hereby amended, Rule XI, Section 68 (h) of the Internal Rules of Procedure of the 10th Sangguniang Panlalawigan of Pangasinan (2019-2022) by deleting the Committee on Games and Amusement;
