DISAPPROVING SB RESOLUTION NO. 43, S-2020 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPALITY OF BANI, PANGASINAN FOR THE CALENDAR YEAR 2021"

**WHEREAS**, the Municipality of Bani, Pangasinan submitted the LGU's Annual Investment Plan for CY 2021 to the Sangguniang Panlalawigan on January 14, 2021;

**WHEREAS**, said Annual Investment Plan was referred to the Provincial Planning and Development Officer of the Province whose opinion and recommendation to remand the same to the municipality was conveyed by the Committee on Laws and Ordinances through its Chairman, SP Member Noel C. Bince, in his letter dated February 3, 2021;

WHEREAS, a committee hearing was scheduled on March 19, 2021, however, the hearing did not materialize since the Sangguniang Panlalawigan received a letter dated March 18, 2021 from Mayor Gwen Palafox-Yamamoto who requested for the rescheduling of said hearing as she was then undergoing mandatory quarantine for having been in close contact with a Covid positive associate;

WHEREAS, the Committee on Laws and Ordinances received a letter dated April 12, 2021 signed by Municipal Vice Mayor Benjamin S. Navarro II, and Sangguniang Bayan Members John Paul T. Navarro, Noel I. Jalania, Armando C. Rivera and Wilhelm C. Aquino, requesting the Committee to have a definite stand on the Annual Investment Plan through a Sangguniang Panlalawigan resolution;

**WHEREAS**, from March 19, 2021 to April 16, 2021, the Committee on Laws and Ordinances did not receive a corrected Annual Investment Plan for CY 2021 of Bani, Pangasinan;
