PROVINCIAL RESOLUTION NO. 392-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A CONTRACT OF LEASE WITH ZOSIMO SALAZAR, FOR THE LEASE OF LINGAYEN DISTRICT HOSPITAL (LDH) CANTEEN

WHEREAS, the Provincial Government of Pangasinan, is the absolute and exclusive owner of the Lingayen District Hospital (LDH) and all structures within its premises, including a Canteen, which is currently vacant at the moment;

WHEREAS, it is necessary that the LDH canteen be made operational in order to cater to the needs of both patients and staff of the said hospital;

WHEREAS, several applicants namely: *Zosimo Salazar, Jennifer Fernandez, Mierasol Delantar, and Servilisa Ibanez*, have expressed their intention to rent/lease the LDH Canteen with an area of 150 square meters, in furtherance of its business of preparing and serving foods and drinks/refreshments, to cater to customers in the area;

WHEREAS, after careful evaluation, the hospital management and the Legal Office considered the proposal of Zosimo Salazar for having submitted the highest bid by undertaking to pay a monthly rental fee of Ten Thousand Pesos (Php 10,000.00) per month;

WHEREAS, this Sanggunian finds that a Contract of Lease is necessary pertaining to the vacant provincial property for the beneficial use/food-and-beverage service provider, of the LDH staff and personnel;

WHEREAS, Section 22 (a) (5) of the same Code states that “*Every local government unit, as a corporation, shall have corporate power to enter into contracts*”;

WHEREAS, Section 22 (c) of the same Code further stipulated that “*Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned*”;


WHEREAS, for the above purpose, the Contract of Lease shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino, III, and Zosimo Salazar;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor Amado I. Espino III, to enter into and sign a Contract of Lease with Zosimo Salazar, for the lease of Lingayen District Hospital (LDH) Canteen;

RESOLVED, FINALLY, that copies of this resolution be furnished to the Provincial Governor, Amado I. Espino III, Province of Pangasinan, and Zosimo Salazar, for their information and guidance.
