**PROVINCIAL RESOLUTION NO. 394-2021**

**AMENDING FURTHER THE INTERIM INTERNAL RULES OF PROCEDURE OF THE 10<sup>TH</sup> SANGGUNIANG PANLALAWIGAN PARTICULARLY ON THE MANNER OF HOLDING OF REGULAR/SPECIAL SESSION DURING THIS TIME OF COVID-19 PANDEMIC**

**WHEREAS**, the Interim Internal Rules of Procedure of the 10<sup>th</sup> Sangguniang Panlalawigan has been amended through Provincial Resolution No. 59-2021 which approved the holding of physical sessions every first and third Monday of the month which shall start at 10:00 a.m. to be held at the Training Center II;

**WHEREAS**, since February 2021, the Sangguniang Panlalawigan has been holding two (2) physical sessions every month in order to have a more passionate and better exchange of ideas as a legislative body in a very conducive and safe place for lawmakers as well as staffmembers;

**WHEREAS**, in March, however, due to the urgency of time to schedule important matters to be discussed and invite personalities in a physical session, the Sangguniang Panlalawigan has scheduled more than 2 physical sessions for the said month;

**WHEREAS**, consequently, there is a need to amend further the provision of the Interim Internal Rules of Procedure of the Sangguniang Panlalawigan by not limiting the holding of physical sessions to two specific Mondays per month;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to amend further, as it is hereby amended further, the Interim Internal Rules of Procedure particularly on the manner of holding Regular/Special Session, as follows:


1. At least two (2) physical sessions shall be held every month but not necessarily on the 1<sup>st</sup> and 3<sup>rd</sup> Monday, with the option to have additional physical sessions should the need arise, and which session shall start at 10:00 a.m. to be held at the Training Center II, Capitol Compound, Lingayen, Pangasinan; and
2. Virtual sessions through video conferencing system which shall start at 10:00 a.m. on remaining Mondays shall be set up when a physical session is not necessary.
