#### **PROVINCIAL RESOLUTION NO. 395-2021**

ENDORSING TO THE PHILIPPINE REGISTRY OF CULTURAL PROPERTIES OFFICE THROUGH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS THE UPDATED INVENTORY OF CULTURAL PROPERTIES/HISTORICAL LANDMARKS UNDER THE DIRECT CARE AND SUPERVISION OF THE PROVINCIAL GOVERNMENT OF PANGASINAN

**WHEREAS**, physical or tangible cultural heritage includes buildings, World War II memorabilia and other works of art depicting the history of the Province are worthy of protection and preservation by the Provincial Government of Pangasinan;

WHEREAS, Section 14 of Republic Act No. 10066, otherwise known as the "National Cultural Heritage Act of 2009" mandates Local Government Units (LGUs) to maintain an inventory of its cultural properties and submit the same to the National Commission for Culture and the Arts to form part of the Philippine Registry of Cultural Properties Office (PRECUP);

**WHEREAS**, the Provincial Government of Pangasinan has been maintaining and updating an inventory, evaluation, and documentation of all its cultural properties and historical landmarks;

WHEREAS, the Provincial Tourism and Cultural Affairs Office has submitted to the Sangguniang Panlalawigan an updated list of official inventory of cultural properties/historical landmarks under the direct care and supervision of the Provincial Government of Pangasinan;
