PROVINCIAL RESOLUTION NO. 397-2019

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO A DEED OF USUFRUCT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES FOR THE USE OF A PARCEL OF LAND CONTAINING AN AREA OF APPROXIMATELY 800 SQUARE METERS WITHIN THE CAPITOL COMPOUND FOR THE ESTABLISHMENT OF ITS PROVINCIAL OFFICE AND/OR CONSTRUCTION OF ITS PROVINCIAL BUILDING

WHEREAS, the Department of Environment and Natural Resources (DENR) Pangasinan Provincial Office is currently located at A.B. Fernandez West, Dagupan City;

WHEREAS, the DENR is desirous to transfer within the vicinity of the Capitol Compound, Lingayen, Pangasinan and has requested the Province that it be allocated with a parcel of land within which they can construct a Three-Storey DENR-Provincial Building;

WHEREAS, the Provincial Engineering Office has conducted a survey and it was determined that the proposed site has an area of approximately 800 square meters which is adjacent to the Training Center and the Justice Hall;

WHEREAS, the Province recognizing the vital role of the DENR in providing extension and on-site research services and facilities such as those related to the effective protection, development, management, rehabilitation and conservation of environment and natural resources, hereby agrees to allow the use of the aforementioned property by way of usufruct to the DENR;

WHEREAS, the term of the usufruct shall be for twenty-five (25) years subject to early termination for just and valid cause, or renewal upon mutual consent and discretion of both parties;


WHEREAS, there is a need for the Sangguniang Panlalawigan to authorize the Honorable Governor, Amado I. Espino III, to enter into a Deed of Usufruct with the DENR granting it the right use of the lot to pave the way for the construction of its provincial building;

NOW, THEREFORE, on motion of SP Members Rosary Gracia P. Perez-Tababa, Liberato Z. Villegas and Noel C. Bince, duly seconded, it was -


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Honorable Governor, Amado I. Espino, III, to enter into a Deed of Usufruct with the Department of Environment and Natural Resources for the use of a parcel of land containing an area of approximately 800 square meters within the Capitol Compound for the establishment of its provincial office and/or construction of its provincial building;
