RESOLUTION NO. 397-2020

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2020 OF MANGATAREM, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P27,000,000.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2020 involving total appropriations of **P27,000,000.00** which was approved on April 2, 2020 through Appropriation Ordinance No. 01, S-2020;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The full implementation of the First Tranche Salary Adjustment to all municipal officials and employees shall be in accordance with the provisions of Local Budget Circular No. 121 of the Department of Budget and Management dated January 24, 2020 Re: Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Republic Act No. 11466;
2. The grant of step increment to some municipal officials and employees shall be in accordance with CSC-DBM Joint Circular No. 01, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016;

3. The purchase of motor vehicle shall be in accordance with the provisions of Administrative Order No. 14 dated December 10, 2018, and its implementing guideline under Budget Circular No. 2019-2 dated March 4, 2019 amending Administrative Order No. 15 dated May 25, 2011, and DILG MC No. 2014-155 as amended by DILG Memorandum Circular No. 2015-52 dated May 11, 2015, and Budget Circular No. 2017-1 dated April 26, 2017 amending Budget Circular No. 2016-5 dated August 22, 2016;
4. The appropriation for Public Affairs Fund and those under the Special Purpose Appropriations be spent solely for public purposes and no amount shall be applied for religious or private purposes pursuant to Section 305 (b) and 335 of RA 7160, and shall be broken down into appropriate objects of expenditures, as may be applicable in accordance with the New Government Accounting system (NGAs);
5. The disbursement of the appropriation for Performance Based Bonus (PBB) for all officials and employees of the municipality shall be subject to the provisions of DILG-DBM Joint Circular No. 2017-4 dated June 7, 2017;
6. The grant of Hazard Pay to government personnel who physically report for work during the period of implementation of an Enhanced Community Quarantine relative to the COVID-19 Outbreak shall be in accordance with the provisions of Administrative Order No. 26 by the President of the Philippines dated March 23, 2020 and Budget Circular No. 2020-1 dated March 24, 2020;
7. The appropriation for the payment of Terminal Leave Benefits (TLB) of retired LGU personnel shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.2 thereof;
8. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations; *and*
9. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;


